## 2024 Food Booth Application

**Food Booth Eligibility:** Due to the smaller size of the venue the WAC **does** have a non-compete clause on all food and drink items **except** bottled water and pop. The show is open to all non-profit groups, youth organizations and commercial vendors interested in selling food. Only the food approved by the Event Committee may be sold. Vendors will be asked to remove all other items. The Event Committee reserves the right to reject any item it deems not acceptable.

**Booth Fees and Insurance:** All vendors must show proof of liability insurance or pay a fee of **\$30** for event coverage through the WAC. If you have your own insurance you must provide a **Certificate of Liability Insurance** with the WAC listed as the Certificate Holder and include the address. Please submit booth fee, proof of insurance, entry form, a stamped, self-addressed business sized envelope and any additional fees by July 1st, 2024. Incomplete applications will be returned without processing. Your fee will be returned if your booth is not accepted.

**License Requirements:** All food booths admitted to the event must obtain/ and provide WAC with a copy of their license from the MDH or MDA. <https://www.health.state.mn.us/communities/environment/food/license/index> Each booth vendor is responsible for obtaining this in advance, and providing a copy to the WAC to have on file during the festival.

**Garbage Cans:** All food booths must bring their own garbage cans for their use and are responsible for placing their trash in the dumpster located nearest to the food court.

**Display:** Booth spaces and display material (stands, tables, chairs, rain cover, etc.) must fit within the space assigned to the vendor.

**Electricity:** If you need electricity please indicate your needs on the form below. It is available an additional fee but vendors must supply their own extension cords.

**Miscellaneous:** The show will be held, rain or shine. The Watermark Art Center and the City of Bemidji will not be responsible for any loss or damage incurred during or after the show.
