BOOTHS: Spaces will be assigned at the discretion of the Festival Committee. Applicants may request a particular space, but we do not guarantee that you will receive it. Participants are responsible for bringing their own tents, tables and chairs, and must have a way of securing their display (anchors, side-walls, etc). Display material (stands, tables, signs, etc.) must fit within the space assigned unless prior arrangements have been made.

FEES & INSURANCE: Watermark and the City of Bemidji require that all vendors either show proof of insurance at a minimum of \$300,000 liability limit or higher OR pay a fee of \$30 for event coverage through the Watermark Art Center. If you have your own insurance you must provide a **Certificate of Liability Insurance** with the WAC listed as the Certificate Holder and include the address. Please submit entry form along with applicable booth fees, proof of insurance and a stamped, self-addressed business sized envelope. Incomplete applications will be returned without processing. Your fee will be returned if your booth is not accepted.

SECURITY: Park Security is provided overnight on Friday and Saturday of the event by the Watermark. While we take every precaution to offer a safe location, the Watermark and the City of Bemidji will not be responsible for any loss or damage incurred at WAF either during festival hours or overnight.

ELECTRICITY: Electrical outlets are available on a limited, first-come first-served basis. If you need electricity, please indicate on the form below and we will do our best to accommodate you. Participants must supply their own extension cords.
